Bidder would be required to register in the website which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in HPPWD may obtain the same from the website: https://hptenders.gov.in. Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in these tenders.

- ii) Cover2: shall contain "BOQ/Financial Bid", where contractor will quote his offer for each item.
- 5. <u>SUBMISSION OF ORIGINAL DOCUMENTS:</u> The bidders are required to submit (a) original demand draft towards the cost of bid document (b) original bid security/Earnest Money Deposit (EMD) in the shape of **Fix deposit receipt duly pledged in the name of EE HPSAMB Shimla** in the <u>O/o Executive Engineer HPSAMB SHIMLA H.P</u> as specified in Key dates at Sr. No. 4.
- **6. BID OPENING DETAILS:** The bids shall be opened on **10.01.2022** at **11:30** HRS in the office of the **Executive Engineer, HPSAMB SHIMLA H.P.** by the authorised officer. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- **7**. The bids for the work shall remain valid for acceptance for a period of **120** days after the deadline date for bid submission.

- **8**. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond his control. Even though the system shall have all updates for the information of bidders but the undersigned shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information related to the tender.
- **9.** The non-responsive contractors can submit their dissent against the tender within three days after opening of Technical bid. Any kind of query/objection will not be entertained after the specified days.
