CONDITIONS OF REGISTRATION	
1. The registration holder shall comply with the provisions of the Himachal Pradesh	
Agricultural and Horticultural Produce Marketing (Development & Regulation) Act, 2005 Act	
No. 20 of 2005 and rules and bye-laws framed there under and instructions issued from time to time.	
2. Registration holder shall not permit evasion or infringement of any of the provisions of the	
Act, the rules and bye-laws made there under and shall report in writing to the Committee about evasion or breach which comes to his knowledge.	

- 3. Registration holder shall surrender his registration on demand to the Secretary against a receipt to be given to the registration holder in this connection.
- 4. Registration holder shall conduct his business honestly and properly according to the principles of fair dealings.
- 5. Registration holder shall keep his business premises clean and in a suitable condition for storage of agricultural produce.
- 6. Registration holder shall not include in activities and practices which are detrimental to the interest of the trade and proper functioning of the market.
- 7. Registration holder shall be responsible for the safe custody and protection of the agricultural produce brought to his shop for sale or storage.
- 8. Registration holder shall get his business premises insured against fire.
- 9. Registration holder shall not form a pool or combination with other buyers for eliminating competition and shall not make or abet an attempt to do so in order to deprive the seller of a fair price of his produce.
- 10. Registration holder shall not treat any agricultural produce with any such chemicals which are hazardous to human health.
- 11. Registration holder shall regularly and promptly attend personally or through an approved representative of auctions held in the market.
- 12. Registration holder shall, on the expiry or sooner termination of the registration, surrender the same to the committee.
- 13. Registration holder shall, when desired by the Secretary of the Committee or any officer authorized by it furnish correct information on the matters pertaining to his business.
- 14. Registration holder shall not take or continue in his service any registered broker, weighmen, measurers, surveyor, hammal (Palledar).
- 15. Registration holder shall not boycott or encourage boycott of any other registration holder.
- 16. The registration is valid for one market year i.e., from 13-Jun-2023 to 31-Mar-2024
